e. PUBLIC COMMENT. Comments should be limited to 3 minutes. There shall be no action taken, nor should there be comments on, responses to, or discussion of a topic not on the agenda. For this meeting parent was allowed additional time considering the topic at hand. Jene Kirkaldy student in law school spoke on behalf of the parent Geneva Kirkaldy "Ms. Jene reading her statement "made multiple request according to CA ED code 47605 required to maintain accurate records and have available at parents requests. The student K. Kirkaldy is being made to write false statements causing him distress; he is having therapy sessions because of this. According to 49000 K. Kirkaldy has the right to physical ed/recess. I am calling to have the Board intervene and uphold the laws of this charter school. Geneva Kirkaldy received and email stating that she cannot communicate with teacher, must go to Tillman. This decision was made without information or explanation. Parents have the right to communicate with teachers. Kingston is being made to sit out recess and write a statement about self; he is being made to write 'I will not join a gang'.

2.0 INFORMATION AND DISCUSSION ITEMS

2.1 Parent Questions Regarding Bullying Issue –

Board member Scott: admin is acting accordingly how can we helo the student succeed **Board member Olguin**: recess is being used wisely; there is a transition plan; if recess in the morning is successful the 2nd recess will be utilized to self reflect

Principal Tillman: Kingston is reflecting daily; the plan is to have him do some reflecting with SEL teacher and by next week recess is granted

Board Scott: Mom, we appreciate you showing up for your student

Board Scott: had questions about the investigative materials – why other student not being comfortable @ play date

Board Member Olguin: its my understanding that the bill regarding recess does not go into effect until the 2024-2025 school year and there are some provisions to that; safety, handle certain situations; interpretation is there are some exceptions to the rule. According to the documentation Kingston is receiving interventions during recess **Scott:** PBIS steps to behvior intervention strategies

Tillman: just to clarify when the students are with me there is "locus parentis" in place in which I am acting as a parent while scholars are in my care; also he is with the SEL coordinator not therapy or counselor

Scott: at my school I ran a group in which we went over 3 skills 1. Following instructions 2. Tone 3. Regulating emotions and discussing the tools and how to implement positive behavior

Olguin: I see there is now a communication plan in place that is very fair and developed by legal counsel...are there any other questions the board may have?

Scott: regarding communication plan, there is a week turn around? If the parent calls on Wednesday they have to wait unti the following Monday

Tillman: yes, 5 days

Scott: how does the parent receive updates?

Tillman: parent has not been receptive so updates have not happened

Olguin: what is the timeline of the communication plan?

Ms. Tillman: until the end of the school year, June 13th

Mrs. James: How is communication updated? Writing? Call?

Tillman: email today, nut not receptive

Ms. Hill (to the parent): is there any reason why the parent is not receptive Geneva Kirkaldy: I have never been given the opportunity

Ms. Tillman: Board, there was have been emails showing outlined intervention and

parents just wants recess restored

There were no other questions of the Board. All agreed administration handled the matter in an appropriate manner
